Notification for modification of procedure prescribed in Clause 6 (छ) of Constitution of Shri All India Shwetambar Sthanakwasi Jain Conference (SAISSJC), New Delhi for filing of nomination of Rashtriya Adhyaksh from Friday, 9th April 2021 to Wednesday, 14th April 2021 between 11 AM to 4 PM in respect process for Chunav 2021-23

प्रांतीय चुनाव अधिकारी के पास राष्ट्रीय अध्यक्ष पद के लिए नामांकन पत्र दाखिल करने की प्रक्रिया

In view of nationwide surge in Covid/Corona and related health hazard as well as mobility restrictions throughout the country, an urgent meeting of Rashtriya Chunav Samiti of Shri All India Shwetambar Sthanakwasi Jain Conference (SAISSJC), New Delhi was held at 01.00 P.M. on Wednesday, 07th April, 2021 on Zoom platform to discuss and consider appropriate modification of the nomination filing procedure pertaining to 'Rashtriya Adhyaksh' as prescribed in Clause 6 (छ) of Constitution of SAISSJC, by exercise of power available to the 'Rashtriya Chunav Samiti' as provided in the note given below Clause 6 (छ), Page 22 of Constitution of SAISSJC. Under the compelling COVID related restrictions and circumstances it was unanimously agreed upon and decided to adopt the following modified procedure in addition to the procedure prescribed in Clause 6 (छ) of Constitution of SAISSJC. The modified procedure as described hereunder shall apply, confine, and restrict itself only in respect of filing of nomination forms of 'Rashtriya Adhyaksh' from Friday, 9th April 2021 to Wednesday, 14th April 2021 between 11 AM to 4 PM in respect process for Chunav 2021-23 and is required to be strictly followed.

As per the modified procedure the nomination forms for the post of Rashtriya Adhyaksh can also be filed with respective Prantiya Chunav Samiti/Adhikari without visiting Jain Bhawan, New Delhi and without appearing in person before Rashtriya Chunav Samiti, by undergoing the following steps:

Step One

- (i) Complete colored scanned copy of the duly filled and signed 'NOMINATION FORM' alongwith all requisites document e.g Pratyashi Jeevan Parichay, proof of payment of Rs 5,00,000/-, three latest passport size photos etc. with copies of Aadhar Card of candidate and all prastavak and samarthak shall be emailed with request for seeking a prior appointment with respective Prantiya Chunav Samiti/Adhikari also stating the preferred date and time of appointment at ecjainconf2021@gmail.com with CC addressed to

- (ii) Email should be sent only from email id belonging to the candidate.

Step Two

- (iii) After receipt of the request from the candidate 'Rashtriya Chunav Samiti' shall intimate the appointed time and date and also send ZOOM link.

Step Three

- (iv) At the appointed time, the candidate shall appear before the Prantiya Chunav Samiti/Adhikari along with two prastavak and two samarthak in person (Maximum five persons) and submit/handover the original nomination form with all required documents to the Prantiya Chunav Samiti/Adhikari on behalf of Rashtriya Chunav Samiti.
- (v) At the appointed time, the zoom link will be active and Rashtriya Chunav Samiti along with Prantiya Chunav Samiti/Adhikari and candidates with his prastavaks and samarthaks will be present on ZOOM and in addition, the candidate can invite and share Zoom link with another six persons (maximum) who can attend and witness the nomination filing process on zoom. These six persons shall be in addition to the candidate, Prastavaks and Smarathaks.

Step Four

- (vi) Prantiya Chunav Samiti/Adhikari shall issue a provisional receipt by endorsing his signatures on photocopy of the nomination form.
- (vii) Final receipt shall be issued by Rashtriya Chunav Samiti at New Delhi and scanned copy shall be sent at the mobile number (whatsapp) or email id of the candidate from official email ID of Rashtriya Chunav Samiti or SAISSJC.
