

Order-

1. This complaint is filed before Rashtriya Chunav Samiti by Shri Ugamraj Jain, LM No 29713- challenging eligibility of Shri Suresh Kumar Lunawat Jain, LM No 051887, who has filed his nomination No 014 for the post of Prantiya Adhyaksh, Zone-I Tamil Nadu which was allowed by the Prantiya Chunav Samiti, Tamil Nadu.
2. The complaint reached Rashtriya Chunav Samiti before 4.00 pm 19th April 2021 and was listed for hearing at 2.30 pm on 21st April 2021 to be held in virtual mode on zoom platform. Complaint was forwarded to Shri Suresh Kumar Lunawat Jain, the affected candidate who filed his reply which is placed on record.
3. During hearing Shri Suresh Kumar Lunawat Jain, the candidate and Shri Tarachandji Dugar Jain, Prantiya Chunav Adhikari, Tamil Nadu, appeared and made their respective submissions which were duly heard.
4. Shri Suresh Kumar Lunawat Jain in his nomination form mentioned his eligibility for filing his nomination as holding one tenure form the year 2018-2020 as Rashtriya Karyakrini Samiti member and two tenures as Prantiya Karyakarini Samiti member for periods i.e. 2014-2016 and 2016-2018 respectively. In his written reply he has reaffirmed the holding of aforesaid three tenures and adduced evidence in support thereof.
5. We find that eligibility of contesting the election for the post of Prantiya Adhyaksh is governed by rule 7 (क) at page no. 22 of Constitution of Shri All India Shwetamber Jain Conference, which defines as
 - (i) Two Tenures in Rashtriya Karyakarini Samiti as member, or
 - (ii) Three Tenures in Prantiya Karyakarini Samitias member, or

- (iii) One Tenure of holding Pad(post) in Rashtriya Karyakarini Samiti, or
(iv) Two Tenures of holding Pad (post) in Prantiya Karyakarini Samiti.
6. While applying the above eligibility criteria for the post of Prantiya Adhyaksh filed by Shri Suresh Kumar Lunawat Jain in his nomination no. 014 for the post of Prantiya Adhyaksh, Zone-I Tamil Nadu holding one tenure form the year 2018-2020 as Rashtriya Karyakrini Samiti and two tenures as Prantiya Karyakarini Samiti for periods i.e. 2014-2016 and 2016-2018, we find that none of the four eligibility criteria as discussed above is satisfied, therefore, he is not qualified/eligible to contest the election of Prantiya Adhyaksh.
7. In the result, the nomination papers no. 014 for the post of Prantiya Adhyaksh, Zone-I Tamil Nadu file by Suresh Kumar Lunawat Jain is hereby rejected.
